RE: Submission on Nominated Candidates for the Deputy Public Protector and SAHRC

- 1. Corruption Watch ("CW") is an anti-corruption non-profit organisation and Transparency International chapter ("TI Chapter"). Our work is centred around countering corruption and advocating for transparent, accountable, and ethical leadership in the public and private sectors.
- 2. Since 2016, we have made written submissions to several committees in Parliament on leadership appointment processes in the legislatures, based on our observations. The aim and spirit of these submissions has been to strengthen and actively contribute to the better functioning of and improved transparency in the appointment processes of Chapter Nine and other related institutions provided for in the Constitution of the Republic of South Africa.
- 3. In this regard, CW has conducted extensive public awareness and advocacy campaigns on leadership appointment processes of Chapter Nine and other related institutions. Furthermore, we have monitored several appointment processes and our proposals for transparent, participatory, and merit-based processes were previously endorsed and recommended by the Judicial Commission of Inquiry into Allegations of State Capture.
- 4. Due to the 10 (TEN) day deadline, we have conducted a screening exercise ("Annexure A") of the candidates who applied for the position of Deputy Public Protector. Kindly note that for the purposes of this exercise we have not attempted to verify the candidates' educational qualifications. In addition, Annexure A makes recommendations to the Portfolio Committee on

Justice and Constitutional Development on the South African Human Rights Commission vacancy advertised on 14 October 2024.

5. Adequate public participation is of paramount interest in the appointment process of the two vacancies of the Deputy Public Protector and South African Human Rights Commission. CW

acknowledges the work of the committee in this process. However, we note the following

concerns:

5.1. The two appointments were advertised at the same time for public comment, with a period of

10 (TEN) days for participation;

5.2. The Deputy Public Protector post attracted 26 (TWENTY-SIX) nominees;

5.3. The South African Human Rights Commission post attracted 45 (FORTY-FIVE) nominees for

one vacancy, impacting the timeline of vetting all the candidates for the post;

5.4. Interested persons therefore have 10 (TEN) days to consider and provide meaningful input on

71 (SEVENTY-ONE) candidates for vacancies on two constitutionally mandated Chapter Nine

institutions. This period is not reasonable in the circumstances.

6. We, therefore, regarding the post of the South African Human Rights Commission, kindly request

that the Portfolio Committee:

6.1. Provides an additional shortlist of candidates for the South African Human Rights Commission

vacancy;

6.2. Grant an extension of the deadlines to allow adequate public participation and scrutiny of the

nominated candidates/applicants, so as to provide meaningful input.

7. We look forward to your response in this regard and can avail ourselves for any queries related

to our inputs.
